

COUNT 1

The Grand Jurors aforesaid, in the name of and on behalf of the citizens of Georgia, do charge and accuse:

with the offense of VIOLATION OF RACKETEER INFLUENCED AND CORRUPT ORGANIZATIONS ACT, O.C.G.A. § 16-14-4(c), for that the said accused persons, in the County of Bibb and State of Georgia, between the 24th day of January, 2025 and the 29th day of May, 2025, did unlawfully, while associated with an enterprise and in violation of O.C.G.A. § 16-14-4(a) and O.C.G.A. § 16-14-4(b), conspire and agree with each other to participate, directly and indirectly, in said enterprise through a pattern of racketeering activity as more particularly

described in Parts I – IV below and incorporated herein by reference, contrary to the laws of the State of Georgia, the good order, peace, and dignity thereof.

PART I: THE CONSPIRACY

The accused conspired and endeavored with each other and other persons known and unknown to the Grand Jury to acquire and maintain, directly and indirectly, an interest in and control of the enterprise, property, controlled substances, and United States currency, through a pattern of racketeering activity or proceeds therefrom.

The accused, in furtherance of the conspiracy and endeavor, performed or caused to be performed at least one overt act to effect the object of the conspiracy.

At least one overt act to effect the object of the conspiracy was performed in Bibb County, Georgia.

PART II: THE ENTERPRISE

At all times relevant to this Count of the Indictment, the enterprise was a group of individuals associated in fact, as listed below, although not a legal entity, who acquired and maintained an interest in and control of the enterprise, said enterprise engaged in the possession, distribution, trafficking and sale of cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and dangerous drugs, and the common goal of said enterprise being pecuniary gain and possession of controlled substances.

PART III: THE SCHEME

The accused engaged in a scheme through a pattern of racketeering activity to obtain and distribute cocaine, a Schedule II controlled substance, methamphetamine, a Schedule II controlled substance, fentanyl, a Schedule I controlled substance, and marijuana, a controlled substance, in Bibb County, for the purpose of selling, purchasing, and otherwise distributing cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances in Violation of the Georgia Controlled Substances Act to various purchasers for their use in Bibb County, Georgia.

Such a pattern of racketeering activity included Violations of the Georgia Controlled Substances Act, including, but not limited to the following: Trafficking Cocaine, Possession of Cocaine with Intent to Distribute, Conspiracy to Traffic Cocaine, Conspiracy to Possess Cocaine with Intent to Distribute, Conspiracy to Sell Cocaine, Possession of Cocaine, Trafficking Methamphetamine, Possession of Methamphetamine with Intent to Distribute, Conspiracy to Traffic Methamphetamine, Conspiracy to Possess Methamphetamine with Intent to Distribute, Conspiracy to Sell Methamphetamine, Possession of Methamphetamine, Trafficking Fentanyl, Possession of Fentanyl with Intent to Distribute, Conspiracy to Traffic Fentanyl, Conspiracy to Possess Fentanyl with Intent to Distribute, Conspiracy to Sell Fentanyl, Possession of Fentanyl, Trafficking Marijuana, Possession of Marijuana with Intent to Distribute, Conspiracy to Traffic Marijuana, Conspiracy to Possess Marijuana with Intent to Distribute, Conspiracy to Sell Marijuana, Possession of Marijana. Additional racketeering activity included, but is not limited to, Illegal Use of a Communications Facilities to Facilitate Violation of Georgia Controlled Substances Act.

It was part of the scheme for the accused to use a cellular telephone as a primary means of communicating with one another in order to arrange the dates, times, locations, prices, and payment for transactions of cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and dangerous drugs in Violation of the Georgia Controlled Substances Act, including trafficking, buying, selling, and otherwise distributing cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and other dangerous drugs.

It was part of the scheme for the accused to arrange the sale or purchase of cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and dangerous drugs in Violation of the Georgia Controlled Substances Act in Bibb County and the middle Georgia area to be sold and used in Bibb County and middle Georgia area.

It was part of the scheme for the accused to utilize cellular telephones and social media apps to arrange to arrange transactions of cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and dangerous drugs in Violation of the Georgia Controlled Substances Act.

It was part of the scheme that the accused utilized the exchange of actual United States' currency, CashApp and other forms of electronic payment and cellular telephone apps to arrange and complete payment for the transactions involving the trafficking, selling, buying, and otherwise distributing of cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and dangerous drugs, as well as the purchasing and using of cocaine, methamphetamine, fentanyl, marijuana, and other controlled substances and dangerous drugs.

It was part of the scheme for **AKBAR HARCLERODE**, **SR.**, **A/K/A ARK**, to communicate, coordinate, and conspire with other members of the enterprise by using the telephone at the Bibb County Law Enforcement Center ("LEC") to discuss selling controlled substances and dangerous drugs to other inmates within the Bibb County LEC and to communicate, coordinate, and conspire with **KIERRA HOWARD AND HASSAN HARCLERODE**, **SR.**, **A/K/A HOT**, for payment of controlled substances and dangerous drugs from other inmates and their family members at the Bibb County LEC in Bibb County, Georgia.

It was part of the scheme for **AKBAR HARCLERODE**, **JR.**, **A/K/A LIL ARK**, to communicate and coordinate with other members of the enterprise to sell and receive payment for cocaine and fentanyl at different locations in Bibb County, Georgia.

It was part of the scheme for HASSAN HARCLERODE, SR., A/K/A HOT, to communicate, coordinate, and conspire with other members of the enterprise to sell and receive payment for cocaine, methamphetamine, marijuana, and other controlled substances and dangerous drugs at his apartment located at 1425 Bailey Avenue, Macon, Bibb County, Georgia, 1347 Bailey Avenue, Macon, Bibb County, Georgia, and other various locations within Bibb County, Georgia. 1347 Bailey Avenue was rented by CHANIKA RANDALL, A/K/A SHAMILL, who is the girlfriend of HASSAN HARCLERODE, SR., A/K/A HOT.

It was part of the scheme for **AKBAR HARCLERODE**, **SR.**, **A/K/A ARK AND HASSAN HARCLERODE**, **SR.**, **A/K/A HOT**, to store large amounts of cocaine, methamphetamine, marijuana, and proceeds from the sale of controlled substances in a storage unit located at 1731 Keystone Street, Macon, Bibb County, Georgia. The storage unit was rented by **KIERRA HOWARD**, who is the girlfriend of **AKBAR HARCLERODE**, **SR.**, **A/K/A ARK**.

It was part of the scheme for THOMAS BUTLER, A/K/A TJ, ARIAS CLYDE, A/K/A A, A/K/A MAFIA, RODNEY CLYDE, KIERRA HOWARD, CLARENCE SMITH, A/K/A DISCO, and GREGORY WOODARD, JR., A/K/A GDUBB to use communication devices to conspire to coordinate the sell, purchase, and payment for controlled substances, including amount of substances to be purchased and amounts to be paid.

It was part of the scheme for AKBAR HARCLERODE, SR., A/K/A ARK AND HASSAN HARCLERODE, SR., A/K/A HOT, to store the proceeds of their illegal drug sales

at the home of Kathy Coker, their mother, located at 1347 Bailey Avenue, Macon, Bibb County, Georgia.

It was part of the scheme for AKBAR HARCLERODE, SR., A/K/A ARK AND HASSAN HARCLERODE, SR., A/K/A HOT to use communication devices to discuss supplying AKBAR HARCLERODE, JR., A/K/A LIL ARK and TYLON EVANS, A/K/A SNAKE, with cocaine and other controlled substances.

It was part of the scheme for **TYLON EVANS**, **A/K/A SNAKE**, to conspire to sell methamphetamine from 3047 Alfred Drive, Macon, Bibb County, Georgia and various other locations in Bibb County, Georgia.

PART IV: THE PATTERN OF RACKETEERING ACTIVITY
