EXECUTIVE ORDER

BY THE GOVERNOR:

- WHEREAS:** Code Section 20-2-73 provides that when a local school system or school has been placed on the level of accreditation immediately preceding loss of accreditation, the State Board of Education shall conduct a hearing to determine whether to recommend the suspension of members of a local board of education; and
- WHEREAS:** The State Board of Education, following such a hearing, recommended to me the suspension of all eligible members of the Dublin City Board of Education; and
- WHEREAS:** On August 17, 2026, I issued Executive Order 08.17.26.01, suspending all eligible members of the Dublin City Board of Education and creating the Dublin City Board of Education Nominating Committee, pursuant to Code Section 20-2-73; and
- WHEREAS:** The Dublin City Board of Education Nominating Committee sent its nominations to me for temporary replacements to appoint to the Dublin City Board of Education on August 31, 2026; and
- WHEREAS:** Code Section 20-2-73 provides that, upon suspension, the Governor shall “appoint temporary replacement members who shall otherwise be qualified to serve” as members of the local board of education; and
- WHEREAS:** Such temporary replacement members shall become permanent members of the local board of education upon the conclusion of the appeal process set forth in Code Section 20-2-73(b) and (c).

NOW, THEREFORE, PURSUANT TO CODE SECTION 20-2-73, AND THE AUTHORITY VESTED IN ME AS GOVERNOR OF THE STATE OF GEORGIA, IT IS HEREBY

ORDERED: That, effective immediately, Teresa Holliday is appointed to the Dublin City Board of Education, District 1 seat.

IT IS FURTHER

ORDERED: That, effective immediately, D'Andrea King is appointed to the Dublin City Board of Education, District 2 seat.

IT IS FURTHER

ORDERED: That, effective immediately, Frederick Green is appointed to the Dublin City Board of Education, District 3 seat.

IT IS FURTHER

ORDERED: That, effective immediately, Priscilla Adams is appointed to the Dublin City Board of Education, District 4 seat.

IT IS FURTHER

ORDERED: That, effective immediately, Angela Wright is appointed to the Dublin City Board of Education, Super District 1 seat.

IT IS FURTHER

ORDERED: That, effective immediately, David Westerfield is appointed to the Dublin City Board of Education, Super District 2 seat.

IT IS FURTHER

ORDERED: That, effective immediately, Douglas Eaves is appointed to the Dublin City Board of Education, At-Large seat.

IT IS FURTHER

ORDERED: That unless a timely petition for reinstatement results in the return of a suspended member to the Dublin City Board of Education, the temporary appointees set forth above shall become permanent members to serve the term of office set forth by Code Section 20-2-73(b) or (c), as applicable.
